#### Terms of Service

The following terms and conditions govern all use of the Vinarkivet website and all content, services and products available at or through the website. Vinarkivet provides services for personal use only, through manual searching only (no automated searches). Excessive/scripted searching may lead to your account being terminated. For API access or commercial use, please contact us.

# Payment and Renewal

**General Terms**. Optional paid services are available on the Website. By purchasing such services, you agree to pay Vinarkivet the one-off or subscription fees indicated for that service. Payments will be charged on a pre-pay basis on the day you purchase the service, and will cover the use of that service for the number of searches or subscription period described. Vinarkivet reserves the right to change the payment terms and fees upon thirty (30) days prior written notice to you.

Minimal Hardware and Software Requirements for Using Vinarkivet. Vinarkivet can be used with any operating system (including mobile) that can run a modern browser (Microsoft Edge, Google Chrome, Safari, Firefox).

**Purchase Process**. Services provided by Vinarkivet can be purchased through the "Kjøp tilgang"/"Purchase access" link that can be reached after logging on to the website. The process works as follows:

- You select the desired plan (tokens or subscriptions)
- Complete the payment with a credit or debit card
- Vinarkivet sends an e-mail mentioning that the purchased service can be used

**Automatic Renewal**.
